

Chair's Report 2023-2024

The Landscape

The focus continues to be on uncertainty in the construction landscape in Australia, with construction being the economy's weakest sector, coupled with static economic growth and an inflation rate that continues to rise.

Existing issues, such as increased labour costs, skills shortage and the rising cost of materials, are some of the biggest issues facing the building and construction industry.

As reported last year, there still remains significant risks in the market for all participants in delivering projects successfully, as evidenced by a continuing rise in insolvent construction companies.

On a more positive note, while construction sector activity has slowed, there are opportunities ahead by diversifying into other project sectors. Significant investment by the Federal Government has been noted in areas such as transportation, renewable energy activity and social infrastructure. Also, the construction industry is increasingly adopting technology to improve efficiency and productivity, which will drive growth.

SoCLA Strategy

SoCLA continues to deliver on its strategic objectives to:

- promote the education, study and research in the field of construction law and related subjects in Australia and overseas; and
- provide a forum for industry participants and thought leaders to connect and together initiate positive change in the construction industry for the benefit of the construction industry and public as a whole by influencing changes to legislation, policy and practice.
